

## About the Club

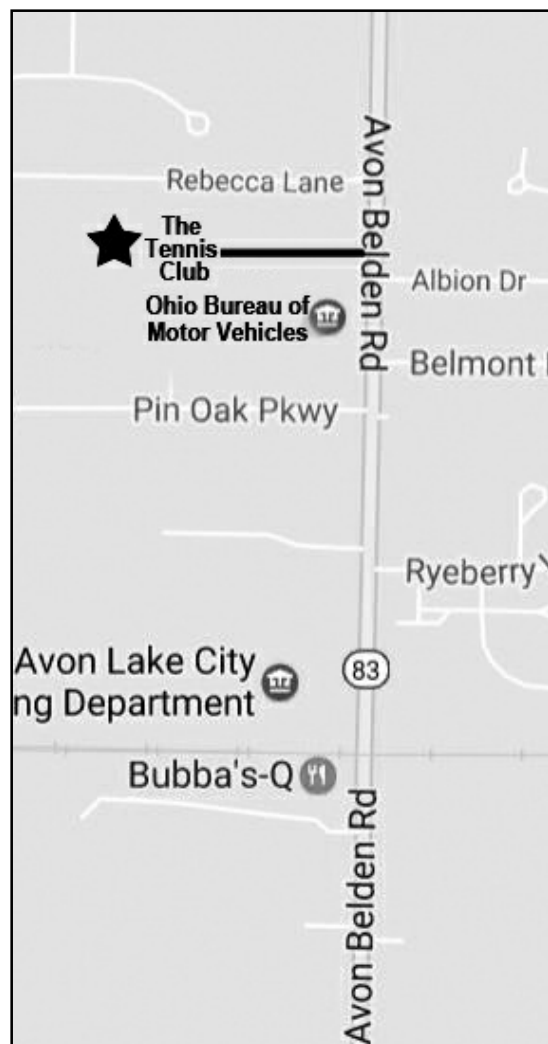
The Tennis Club is a unique, outdoor member owned club located on Rte. 83 in Avon Lake, Ohio. It features eight carefully maintained Har-Tru courts and 200 tennis-loving members. Drawing from all over Lorain and Cuyahoga counties, The Tennis Club offers all the benefits of a conventional club without the high initiation fees or mandatory monthly spending.

- The Club provides high quality outdoor tennis at a very reasonable cost.
- Members range in age from children to adults in their 80's at all levels of play
- Social events are planned by the members throughout the summer
- Tennis is the sole athletic activity offered and parking is free
- The club is owned by its members, who are completely responsible for its management. Members may choose to join as an owner, "Corporation" member or as a social, "Club" member, which does not include ownership.
- On week ends and evenings, players can usually find a singles or doubles game without arranging ahead. Many members play during the week on a casual, "whoever shows up, plays" basis. Cookouts and socializing make the daily play even more enjoyable.
- On Friday nights and Sunday afternoons, there are casual gatherings that include singles, doubles & mixed doubles play. No reservations required! Everyone plays at these gatherings!

## Location

The Tennis Club is located at 676 Avon-Belden Road (Rte. 83), midway between the Rte. 83 exit on I-90 and Walker Road, less than a half-mile north of the railroad tracks.

**2019 — 3-Year  
New Club Member Trial Program**

The Tennis Club Trustees approved a special 3- year trial membership program for 2019.

The program enables local tennis players to join the club at greatly reduced fees for the first three years and allows them to pay the \$200 initiation fee over a 3-year period. In the 4th year, the regular dues take effect. See the chart below.

There is a **Junior Single Membership** For those under the age of 21. The fee is \$150 per year with no initiation fee requirement. To retain membership when a player turns 21, the \$200 Club Member Initiation Fee shall be paid plus the annual membership fee.

NOTE: Under the special 3-year new member program, the initiation fee is paid over a 3-year term. There is no initiation fee due the 1st year; 2nd year is \$75; 3rd year is \$125.

**Standard Fees**

**The Tennis Club has a

Membership Dues are payable yearly.  
Current Dues: \$300 Single; \$425 Family

There are NO additional hourly court fees.

**3-Year Trial Membership  
Terms & Conditions**

1. The Three (3) Year Trial Membership is a special membership program for 2019.
2. The 3 Year Trial Membership is not available to any current active or inactive member or former member who has been active within the past four (4) years. Former members who have not been active members at TTC in the past four years may rejoin under this 3 Year Trial Membership program.
3. If a member participating in this program becomes injured and wishes to go on the inactive list for the full second or third years of the program they would be required to pay either the \$75 Second Year fee or \$125 Third Year fee and would relinquish their playing rights for that year. The member could return to active status as either a Third Year or Fourth Year member depending on their year of inactive status. No individual or family may be inactive for more than two consecutive years.

4. New members have a one time offer to participate in the 3 Year Trial Membership program. An individual or family will not be permitted to start the program, drop out (for reasons other than injury) and rejoin under this program at a later date. If they start, drop out and wish to join at a later date they will be required to pay either the \$200 Club Membership fee or the \$500 Corporation Owner Membership fee (if they wish to become an Owner Member) in the first year of rejoining the Club.
