Rules to Play By

Guests - A non-member may only play a TOTAL OF THREE times in one season. Members who invite non-members to play must determine if that person has already played as a guest with anyone else. If they have already played three times, they are not eligible as a guest -- even if they have not played with you!

If any member observes that a guest has played more than 3 times, notify a Board member. It is the Board's responsibility to deal with it.

Court Sign Up - Remember to sign up on the white board on the fence to play. Courts are first come, first play ... there are no reserved times.

If all the courts are taken, sign your name on the "waiting to play" area. The first available court will go to the name at the top of the list.

If your playing partner(s) have not arrived, you may not hold a court while others are waiting. You must keep your name on the "waiting to play" list until your playing partner(s) arrive.

When people are waiting to play, doubles are limited to 1-1/2 hours and singles to 1 hour.

If you are playing singles and your time is up, you must come off the court for the next in line. You may not invite someone else further down on the list to play doubles with you and start your time again.
