You will notice that there has been a slight increase in membership dues. While our expenses have been increasing each year, our membership dues have not increased since 2012.

For the past couple of years, The Tennis Club finished with a loss of more than \$2,000 so the Board found it necessary to increase the membership dues as well as

to eliminate the "Owner Discount" which owners enjoyed for the last three years.
